Application Details

Dilute 1 part product to 10 parts water. Apply 4-6 gallons of concentrate per acre; through fertigation or spray applicator. Timing and frequency of application should be based on soil and tissue testing.

Use alone or with any common-use fertilizers. Jar test if unsure of compatibility. Shake or circulate before use.

Storage and Handling

Store in original container in a cold dry place out of direct sunlight. DO not allow product to freeze. In case of accidental exposure, flush with water. Product is non-hazardous. May stain clothing.
